BACKGROUND: What is the ULMWP?

SARALANA DECLARATION ON WEST PAPUA UNITY

We the undersigned; the Federal Republic for West Papua (NRFPB), West Papua National Coalition of Liberation (WPNCL), West Papua National Parliament (WPNP/New Guinea Raad), have conducted the Summit on West Papuan Unification at Saralana, Port Vila, Vanuatu, from 30th November – 6th December 2014.

In the name of the people, the nation and the land of West Papua, we do declare that today the 6th December 2014 at the Chief's Nakamal, at Saralana, Port Vila, Vanuatu, that the undersigned groups have united and established the United Liberation Movement for West Papua (ULMWP), a body representing all resistance organisations both inside and outside West Papua.

We declare and claim that all West Papuans, both inside and outside West Papua, are united under this new body and that we will continue our struggle for independence.

This meeting has been conducted pursuant to the decision made by the Melanesian Spearhead Group (MSG) in Port Moresby, Papua New Guinea in June 2014, that West Papuan independence organisations must first unite before an application for membership can be re-submitted to the Melanesian Spearhead Group (MSG). We are now united and will re-submit an application under this new body, the ULMWP.

We are determined that the United Liberation Movement for West Papua (ULMWP) becomes the coordinating body to support all international efforts to regain our sovereignty. In order to support this, we have formed a secretariat of five people; Benny Wenda, Jacob Rumbiak, Leone Tanggahma, Octovianus Mote and Rex Rumakiek, and representing the three largest resistance organisations and also all non-affiliated resistance organisations that support our struggle. We will maintain our existing organisations but commit to be united by the coordinating efforts of the United Liberation Movement for West Papua.

This important and historic declaration has been made possible through the faithful efforts of the Vanuatu Government, Malvatumauri National Council of Chiefs, the Vanuatu Christian Council, the Pacific Conference of Churches and the commitment of the following liberation organisations:

This Declaration is signed at the Chiefs' Nakamal, Port Vila, on this day Sixth of December, Two Thousand and Fourteen, by:

The United Liberation Movement for West Papua (ULMWP), formed in 2014 during a week-long summit in Vanuatu that culminated in the Saralana Declaration. The Summit, a regional initiative by church and women across Melanesia, was sparked by the 2013 World Council of Churches Assembly in South Korea; was supported by West Papua's *Gereja Kristen Injili* Church; sponsored by the Vanuatu Government and Pacific Conference of Churches; and mediated by the Vanuatu Christian Council and Malvatumauri National Council of Chiefs.

The ULMWP was elected from and is accountable to the nation's key political identities—the West Papua National Parliament (KNPB), West Papua National Coalition for Liberation, and Federal Republic of West Papua (FRWP). Since its formation West Papua's independence case has been actively prosecuted by a coalition of Pacific states led by Vanuatu and the Solomon Islands. In 2019 the Pacific Islands Forum (18 UN member-states) and the Africa Caribbean Pacific Group (79 UN member-states) passed their first motions of support, urging Indonesia to allow the UN Fact Finding Mission it agreed to in 2017. In 2020-2021 the governments of the UK, Netherlands, Spain, and Poland, as well as the European Union passed similar legislation.

West Papua's quest for freedom

Melanesia is still incomplete without West Papua being a member of the Melanesian Spear Head Group and gained its independence from Indonesia, says visiting executive officer of United Liberation Movement for West Papua Jacob Umbiak.

Umbiak who is in the country uttered these words yesterday in an erclusive interview with the paper.

He said if Solomon Islands is a true Melanesian country and brother, it will support the cry of its brothers and sisters of West Papua for 'freedom'.

"Please support West Papua in Melanesian Spearhead Group (MSG) to become full member of MSG because if West Papua is in MSG, Melanesia is fully complete," Umbiak said.

He begged Solomon Islands and all Melanesian leaders to support West Papua in their fight to get independence. Umbiak said, by freeing West Papus,it will uphold sovereignty, dignity and identity of Melanesians in full and not half.

"By supporting the independence of West Papua it will stop misunderstanding between Indonesia and Pacific Island countries, between Indonesia and Australia, Asia and all countries around the world.

"Independence of West Papua will of course benefit Indonesia, Melanesian countries and the world and will be a blessing and no one will win or lose," Umbiak said.

He said to become noble people in the world, we have to start freeing ourselves in our own area before we free the world.

"Because our mission to the world is to free the world and make it a safe place, peaceful and bring justice and love to all people around the world...and we need to start from our region of Melanesia...that is why West Papua should be independent so that

Melanesia should be totally free and the world should also be free," Umbiak added.

Umbiak said, his visit to the Solomon's who is a Melanesian brother is to share with the government and people of the country the suffering of West Papuans which they believe is the suffering of all Melanesians

"I can't go far to Europe, Asia or other countries because they are not Melanesians. But I can only share with my Melanesian brothers in Melanesian territo-

ries," Umbiak stressed. The ULMWP executive officer further highlighted that his coming to the Solomon is to share the philosophy of the truth.

"...voice of the people is the voice of god and voice of god is the voice of truth," Umbiak said.

He said the grassroots people, the churches, the government and opposition are the four key groups that can unite to make the right agenda to help West Papua get into MSG. "...as Melanesian leader you have to make the right decision to protect Melanesian people, territory, resources and most of all to uphold Melanesian dignity, sovereignty and identity," Umbiak said

Adding he will continue to explain to governments to accept West Papua in MSG because they have the same right to be part of MSG and secondly have the right to make decisions and not Jakarta to make decisions for them.

"Decision making of Melanesian leaders should show real Melanesians the real leader and uphold their real identity as Melanesians and not to be dictated by Indonesia or those from outside.

"Secondly the Solomon islands government can make their decision to show the international community that Melanesian leaders should protect and uphold their identity, sovereignty and dignity," Umbiak stressed.

He begged all Melanesian leaders not to listen to Indonesia and make their own independent decisions as Melanesian leaders.

Adding, the problem of West Papuans is a Melanesian problem and it will be a real test for all MSG leaders to prove if they are truly Melanesian leaders or some kind of a Indonesian or foreign Puppet.

"If Solomon Islands government and people have the right to gain independence just like any other nation that gains its independence, why can't Solomon Islands government and its people support West Papua to achieve the same for their freedom."

Meanwhile Umbiak said, they respect bilateral ties Solomon Islands government have with Indonesia as that is an United Nations ethics and that is normal of any country.

"But talking about sovereignty, dignity and the rights of West Papuans, Solomon should tell Indonesia let West Papua free because they are Melanesians," Umbiak slammed.

He said, all nations have the right to independence and Indonesia should respect their right for independence.

Meanwhile Umbiak and his 3 man team will be organising meetings with the grassroots groups, the government, opposition, and other organisations seeking full support to their plight for full membership of MSG and to gain independence from Indonesia.

Movement gets Solidarity support

THE United Liberation Movement For West Papua (ULMWP) gets the full support of Solomon Islands for West Papua Solidarity group.

Support was granted in full to the visiting ULMWP Executive officer, Jacob Rumbiak who is currently in the country on campaign rally for full MSG membership for West Papua.

Solomon Islands Solidarity For West Papua Secretary, Lilly Chekana said Solomon Islands Solidarity's campaign for West Papua is no mistake.

"We fully support the cause and we need to see our brothers and sisters become part of us Melanesians."

She assured Mr Rumbiak, there is no sitting on the fence on this issue of West Papua, and Solomon Papua will not reserve any space.

"Reserving that support is for the lame, we stand our grounds as Melanesians, as pacific islanders in the region with our full support.

"Not until West Papua is free of genocide and torture, pacific people are yet to have their freedom to human rights and freedom of expression.

"It is a destiny that we as pacific islanders and Melanesians should have equal share to, leaving no one behind," she stressed.

Jacob Rumbiak welcomes the support and said it is their wish to become a full member of the Melanesian Spearhead group.

"As Melanesians we are entitled to, nothing should stop us unless political influence and money diplomacy hinders that.

"But the ideal campaign

Melanesians and of the pacific we are part of the region."

He said the support from the Solomon Islands Solidarity for West Papua is overwhelming and hopeful that at the political level there is no sitting on the fence on this issue.

"Our innocent people have suffered for over 50 years and we are asking your good support as Melanesian brothers and sisters. our freedom is our only call and hope, that a country with a name following King Solomon himself, there will be wise and knowledgeable leaders and people to support our campaign for full MSG membership."

Call to end Papua media black-out

Dozens of demonstrators dressed in black gathered outside the Indonesian Embassy in London last week to lead the global protest against West Papua's 50year long isolation.

The demonstration was organised by TAPOL and Survival International, supported by Amnesty UK and the Free West Papua Campaign.

The rally was one of 22 protests around the world on Wednesday calling for free and open access to Indonesia's most secretive region.

Since West Papua's annexation in 1963, Indonesia has imposed a media blackout on the contested, resource-rich territory, allowing perpetrators of human rights violations to act with total impunity.

West Papua is one of the world's most isolated conflict spots. For decades, Indonesian security forces have brutally suppressed Papuan pro-independence movements.

The "Global Day of Action for Free and Open Access to Papua" has sparked rallies in West Papua, Indonesia, Australia, New Zealand, the Solomon Islands, Scotland, Germany, France, Italy and Spain.

Unprecedented protests

Protests in Los Angeles, New York and San Francisco also took place after the London rally. This global coordinated effort, the first of its kind, shows that worldwide solidarity for West Papua has reached unprecedented levels.

Esther Cann from TA-POL, a London-based NGO coordinating the rally, said: "This is the first time we've seen anything like this level of support for West Papua.

NGOs, parliamentarians and solidarity groups all around the world are telling Indonesia that human rights abuses in Papua can no longer be ignored.

Papuan voices must be heard. In this age of information, it's astounding that there are blackspot regions like West Papua."

From the Solomon Islands to Scotland to San Francisco, hundreds of demonstrators from 22 cities in 10 different countries united to call for a free and open West Papua.

Demonstrators wore black, representing the ongoing media blackout in West Papua. They gathered to demand that President Joko Widodo fulfill his presidential campaign promise of opening West Papua to international journalists. humanitarian and human rights organisations.

A three-minute silence was observed to symbolise the silencing of the media in West Papua.

"President Jokowi himself has said that there is nothing to hide in Papua. So why is it still virtually impossible for journalists and NGOs to report on Papua? We know that serious human rights violations are happening in Papua, but we still have no idea of the scale of the killings and torture over the last 50 years," said Cann.

Outing the truth

"This global day of action is our way of telling the Indonesian government that the world is watching.

"Even though they've kept West Papua isolated for 50 years, the world has not forgotten. The truth must and will come out," said human rights activist Peter Tatchell, who took part in the protest.

At the end of the demonstration, a joint letter to President Jokowi signed by 52 Papuan, Indonesian and international groups and parliamentarians' was delivered to the Indonesian Embassy in London.

The letter pointed out that "the media blackout denies the Papuan people the right to have their voices heard and allows human rights violations such as killings, torture and arbitrary arrests, to continue with impunity

The de-facto ban on foreign journalists, NGOs and humanitarian organisations contributes to the isolation of local journalists, and makes independent investigation and corroboration virtually impossible".

An Avaaz petition calling for media freedom in West Papua, launched by the Free West Papua Campaign and signed by more than 47,000 people was delivered to President Jokowi by Papuan students in Jakarta today.

Reporters without Borders, a co-signatory to the joint letter, criticised Indonesia's decline in media freedom.

Henjamin Ismail, the head of the Asia-Pacific Desk at Reporters without Borders said "Indonesia's ranking in the World Press Freedom Index has worsened dramatically in the last four years.

"In 2015, it ranked 138 out of 180 countries. This year's position is mainly the result of the media blackout in West Papua orchestrated by the authorities."

Observers barred

Access for UN human rights observers has been closed for eight years. In recent years, international humanitarian agencies and NGOs have been pressured to close their field offices and leave Papua.

International journalists and NGOs seeking to visit and work in Papua are currently required to undergo a stringent visa application process involving the unanimous approval of 18 separate government agencies known as the Clearing House committee.

In October last year, two French journalists were sentenced to 11 weeks in detention under immigration charges because they had tried to report the Papua conflict.

During a UN Human Rights Council event last month, Valentine Hourrat, one of the two journalists detained, stated that "... keeping Papua closed to journalists means that the Indonesian authorities are hiding human rights violations. As journalists we cannot let a murderous silence prevail."

Independent reporting by local and national journalists in Papua is dangerous and sometimes lethal. According to the Papuan branch of Indonesia" Alliance of Independent Journalists (Aliansi Jurnalis Independen, AJI), in 2014 there were 20 reported cases of violence and intimidation against journalists in Papua.

"Journalists must be able to work without intimidation, threats or restriction. We should be able to report independently and without fear for our security. Why is this not guaranteed to journalists in Papua? As Indonesian citizens, why are our rights not safeguarded?" said Oktovianus Pogau, a journalist with Suara Papua, a Papuan news site.

During his presidential campaign, President Joko Widodo publically stated that there was nothing to hide in Papua and promised to open the region. Yet six months into his presidency, Papua remains closed off to the international community.

While President Widodo has pledged his commitment to resolve past rights abuses, the execution of eight people for alleged drug trafficking offences less than 24 hours before the London rally put the future direction of Indonesia's human rights into serious question.

Milner Tozaka (Minister for Foreign Affairs) whose dogged pursuit of justice produced the first recognition by an international organization of the West Papuans' independence struggle. The shift brought the Papuans—as they say—out of the darkness into the light.

We write to address issues arising from the dismissal by Prime Ministers O'Neill and Bainimarama of our application to become a member of the Melanesian Spearhead Group (MSG), which has derailed the negotiating process leading up to the Melanesian Spearhead Group Summit in Honiara in June 2015. The application was prepared by the United Liberation Movement for West Papua (ULMWP), and presented to the MSG Secretariat by the Vanuatu Government on 4 February 2015.

The Special MSG Leaders Summit in Port Moresby on 26 June 2014 recommended 'an inclusive, united, representative body' underwrite West Papua's application. In December 2014, during the *Reconciliation and Unity Summit for West Papuan Leaders* in Port Vila, the ULMWP was elected from i) Federal Republic of West Papua—Octo Mote, Jacob Rumbiak; ii) West Papua National Coalition for Liberation—Leonie Tanggahma, Rex Rumakiek; and iii) West Papua National Parliament—Benny Wenda.

The Unity Summit was initiated by the 2013 World Council of Churches Assembly in Busan, South Korea; propelled by the Protestant Church in West Papua (*Gereja Kristen Injili*) and Lutheran Church in PNG; sponsored by the Vanuatu Government; moderated by Malvatumauri National Council of Chiefs, Vanuatu Christian Council, and Pacific Conference of Churches.

Rather than embrace the ULMWP application for a seat at the negotiating table, Ministers O'Neill and Bainimarama have pledged their support for Indonesia to have five of its governors, two of which are West Papuan, as an Associate Member of the MSG. Note that the two Papuan governors are not freely elected, but pre-selected as election-candidates by LEMHANAS, a powerful Indonesian institution that is directly answerable to the President and tasked to maintain and protect Indonesia's 'territorial integrity'.

On 14 May 2015, Prime Minister O'Neill misled the Lowy Institute in Sydney with his claims of eleven million Melanesians in Indonesia, and the aggregate number of Melanesians exceeding Australia's population of twenty-three million. The issue for this leader of the largest Melanesian

state should not have been how many Melanesians live in Indonesia, but how many are dead and dying in West Papua.

In 1962, Melanesians constituted 99% of the population in West Papua. By 2010, they were 48.7% (1.7 of 3.6 million) with an annual growth rate of 1.8% (the non-Papuan rate was 10.8%). In 2020 Melanesian West Papuans will be 'a small and rapidly dwindling minority of just 28%' (J Elmslie, University of Sydney *West Papuan demographic transition and the 2010 Census: Slow Motion Genocide or not?*)


Minister O'Neill said his arrangement with President Widodo would "ensure peace, stability, and development for Melanesians in West Papua". Nine days after their meeting on 11 May 2015, Indonesian police arrested 70 Papuans in Manokwari for supporting the ULMWP application; their tear gas hospitalizing dozens of children. On 28 May, 46 Papuans were arrested in Jayapura. In March, Benny Wenda (ULMWP Spokesperson seriously assaulted in Port Moresby last July) was refused entry into PNG. Markus Haluk, another leader, was also assaulted in Port Moresby, and robbed of the funds collected in West Papua for Cyclone Pam victims in Vanuatu.

The ULMWP believes the MSG should shepherd West Papuans into its sphere because it is an appropriate forum for negotiations with Indonesia. Indeed, by gracing their Melanesian kin with full membership, MSG politicians will demonstrate their leadership, their dignity, and their sovereignty, and enhance the MSG's status as a UN-accredited International Organization.

PNG and Fiji are obliged to the MSG Founding Principles 'to defend and promote independence as the inalienable right of the indigenous peoples of Melanesia', and 'to contribute to a peaceful, secure, and stable democratic environment throughout Melanesia'. The ULMWP believes the MSG is as capable of negotiating justice and peace for West Papuans as the Asian African Conference is of carrying Palestine's self-determination claims (confirmed during AAC Commemorative Summit in Bandung in April 2015).

Speaking for the Melanesians of West Papua, the ULMWP now demands answers of the MSG Leaders. When is enough, enough? How long before the leadership stands for justice over genocide? Life over death? Indigenous custody of land over global exploitation of their resources? Should a Melanesian grandchild be allowed to sell his ancestral parent for blood-gold and crimson-copper?

Jacob Rumbiak, Minister for Foreign Affairs, Immigration & Trade of the Federal Republic of West Papua, Comrades and Colleagues, it is a great honour to be here with you this evening and join with you on this historic occasion.

Fifteen years ago, on 24 October 2000, the ACTU along with many ACTU affiliates and Dr Jacob Rumbiak signed a Memorandum of Understanding concerning West Papua. The purpose of that Memorandum was to express solidarity with the aspirations of the West Papua people; and to effect, through national and international avenues, a peaceful resolution of their self-determination process that was aborted by the international community in 1962.

As that MoU notes, a 'Referendum' in 1969 is seen by some to have delivered West Papua to the Indonesian Republic. A posse of people specially selected by Indonesia to vote on behalf of all West Papuans is not democracy. The 1969 referendum was no Act of Free Choice. The 2000 MoU called for an urgent Inquiry by the United Nations into the suffering and deaths in West Papua at the hands of the Indonesian military, and for an internationally supervised United Nations sponsored referendum – a true Act of Free Choice by the West Papuan people.

Regrettably, over the past fifteen years there has been a ceaseless stream of authoritative reports of continuing human rights violations in West Papua, of murders and beatings and intimidation of civilians advocating for independence, at the hands of the Indonesian military. In the face of sustained intimidation, West Papuan activists have continued the struggle – for recognition, for peace, for freedom of expression, for the right to exercise a true Act of Free Choice.

Jacob (Rumbiak), we salute you, and all your colleagues who have sustained the struggle and kept hope alive.

The Federal Republic of West Papua was established as a declarative state in 2011 and late last year a committee, the United Liberation Movement for West Papua (ULMWP) was formed to carry an application for full West Papuan membership of the Melanesian Spearhead Group. The ULMWP brings together the Federal Republic of West Papua, the West Papuan Coalition for Liberation, and the West Papuan National Parliament, and with this single united voice their application for membership was presented by the Vanuatu Prime Minister to the Melanesian Spearhead Group Secretariat on 4 February this year. That application for membership of the MSG will be determined next month in Honiara.

Today we are signing a new Memorandum of Understanding. It commits the ACTU and those Australian unions who are signatory to the MoU to recognise the Federal Republic of West Papua; to support the application by the United Liberation Movement for West Papua for full membership of the Melanesian Spearhead Group; and to promote the right of West Papua to self-determination consistent with UN Principles.

Let there be no misunderstanding – we support peaceful resolution of these matters. We support human rights. The murders and mutilations must stop. Oppression and intimidation are no path to a peaceful future. Genuine dialogue must be nurtured and grow. The voice of the West Papuan people must be heard and respected. On behalf of the ACTU, I am proud to be here today and proud to sign this Memorandum of Understanding.

During this Mass, three days before the MSG Summit, Bishop Alfred Karibongi announced a three-day Prayer-and-Fast for West Papua. This was in response to announcements by PNG and Fiji that they were rejecting ULMWP's application to join the MSG, and by Vanuatu's (new) Prime Minister Sato Kilman that he would not be attending the summit.

In April Sato Kilman, as Foreign Affairs Minister, flew to Jakarta for the Asia-Africa Conference (!) where he agreed to open Vanuatu's first embassy in Indonesia. He was immediately demoted from Foreign Affairs, but managed to galvanise a no-confidence motion against Prime Minister Natuman—who supported West Papua's MSG application, and was then himself elected Prime Minister!



In Melbourne on 9 November 2002, Vanuatu Chief Morris Kaloran ritually sacrificed a pig called Yabon, and wrapped it inside a Morning Star flag. The ceremony opened a Melanesian seminar YUMI WAINTAIM (you-me-together) in the Kulin Nations' Wurrundjeri Gardens on the banks of the Maribyrnong River.

The second part of the ceremony took place in All Saints Anglican Church in St Kilda, where parts of the (now-cooked) pig and the bloodied flag were blessed by an assembly of priests and pastors that included Rev. Janet Turbie-Johnston (an Anglican Aboriginal priest from the Gundjitamara nation), and Catholic Bishop Hilton Deakin. West Papua's Morning Star flag flew from the church mast for the next twelve months.

In November 2007, the flag was taken to Vanuatu for a similar cultural-political ceremony prior to the signing of a ground-breaking UNITY DAY DECLARATION between the West Papua National Authority, the Maraki Vanuariki Council of Chiefs, and the Port Vila Council of Chiefs.

In June 2015, the Federal Republic of West Papua Womens Office, supported by Australian trade unions (which had just signed a Memorandum of Understanding with the FRWP), delivered two pigs to the MSG Summit in Honiara. Yabon's flag was carried in the WP4MSG Rally. The flag was then returned to the Federal Republic of West Papua office in Docklands (Victoria).

'Iron Bottom Bay' derives its name from the 200 ships and 690 aircraft that (still) lie within it, after WWII air-and-naval battles in 1942-43. (The wrecks include the Royal Australian Navy cruiser *HMAS Canberra* that was struck and damaged by the Japanese on 9 August 1942. Two American destroyers, *USS Ellet* and *USS Selfridge*, then scuttled and sank the cruiser in Ironbottom Bay instead of towing it to Tulagi Harbour for repairs. xxv) Applications for Membership by United Liberation Movement for West Papua (ULMWP) and Associate Membership by Indonesia

a) On the application by ULMWP for Membership, Leaders approved that ULMWP be admitted as an Observer member under the regional and international category representing Melanesians living abroad.

b) On the application by Indonesia for Associate Membership, Leaders approved that Associate membership be accorded to Indonesia representing the five (5) Melanesian Provinces in Indonesia. The 2015 MSG accorded West Papua diplomatic status as 'Observer'.

Indonesia's campaign to prevent this included high-level visits to Port Moresby, Suva, and Honiara; an offer of \$us20,000,000 for MSG capacity-building; and a huge delegation in Honiara.

Indonesia also applied for five of its governors (of what it now calls its 'melanesian' provinces) to be accorded 'MSG Associate' status, even though the republic never has, and continues to refuse to recognize its indigenous populations. The two West Papuan governors refused to come to Honiara.

Manasseh Sogavare had to outwit the dismissal of West Papua's MSG application by PNG Prime Minister O'Neill and Fiji Prime Minister Frank Baimimarama.

Rather than embrace the ULMWP application for a seat at the MSG negotiating table, O'Neill and Bainimarama pledged their support for Indonesia to have five of its 'melanesian' governors as MSG Associate Members. These governors are not freely elected but are preselected as election-candidates by LEMHANAS, an Indonesian institution directly answerable to the President and tasked to maintain Indonesia's 'territorial integrity'. The two West Papuan governors refused to come to Honiara.

Andrew Johnson took issue with 'untrue statements' by Fiji and Indonesia at the MSG Summit:

".... The Indonesian delegate claimed that the United Nations made a resolution granting Indonesia sovereignty over West Papua, and Fiji's Prime Minister is telling the MSG gathering that "Indonesian sovereignty over West Papua cannot be questioned." But neither of those statements are true....

.... I wrote a draft UNGA resolution that the Vanuatu Parliament wanted to tender five years ago, asking that the International Court of Justice advise whether West Papua is legally part of Indonesia, or is a non-self-governing territory.

.... I believe that West Papua is a UN Trust Territory, due to Indonesia asking and the UN General Assembly putting UN Charter Article 85:Part 1 into effect in UNGA Res. 1752. This compels UN members to promote West Papua towards independence under Article 76 of the UN Charter.

.... Whether I am correct, or the Fijian PM is correct, is a matter that only the International Court of Justice (ICJ) can answer. The MSG has raised the issue of the sovereignty, and I think our governments need to ask the ICJ to determine whether West Papua is a UN trust territory or not".

INDONESIAN DELEGATES PROTEST AT MSG FORUM OVER SPEECH BY PAPUAN INDEPENDENCE LEADER

<u>Tabloid Jubi, Jayapura, 27 June 2015 (Victor Mambor)</u> – Indonesian delegation reacted strongly to a speech by the United Liberation Movement of West Papua (ULMWP) at a meeting of the Melanesian Spearhead Group.

Sec-General Oktovianus Mote said ULMWP stood before MSG to affirm that the group has fulfilled the requirements demanded by the MSG at a meeting in Noumea, New Caledonia in 2013.

"The people of West Papua are united under ULMWP leadership. And our unity is supported by the Melanesian people. Our leadership has been legitimized by the people who signed the petition supporting ULMWP application for full membership. Many of the applicants have been arrested, imprisoned and tortured" Mote said.

Mandy Setyawati, who led the Indonesian delegation, released a statement denouncing the speech.

"We reject all accusations that are unfounded and false submitted by an organization calling themselves ULMWP. We have absolutely no interest in taking advantage of this forum in things that are not productive and constructive" the Indonesian delegation said in the statement released to reporters in Honiara.

The Indonesian delegation also said that, as a democracy, Indonesia respects the law and quality under the rule of the Indonesian state.
