#### **CLOVIS A. MWAMBA, BIOGRAPHY**

## The school as an open window for the rising Congolese Nation-State

I was born into a working class family in the rich mining province of Katanga in eastern Congo. I have an undergraduate degree in Educational Sciences (1969) and a Master degree in Psychology (1972) and in French and African Linguistics (1980).

I became a teacher (1972), a secondary school principal (1975), Chief of the Division of Education (1976) and Chief of the Regional Bureau of Education in Western Kasai province (1979). Between 1973 and 19781 I also organised and spoke at psychology and education seminars for teachers, school inspectors, and jurors from the State Examination Board. Between 1984 and 1990, during my doctoral studies at the National University, I published dozens of articles and papers on Ethnopsychology and Traditional (oral) Luba Literature.

# The 'unknown Luba child' within the Congolese urban subculture

I work hard to unveil the Luba oral tradition—a databank of secular knowledge and myths, tales and proverbs—because I believe it is a form of 'collective therapy' for 'dealing with the unknown other.'

### The fall of Mobutu's one-party-state and right-wing military regime

By the end of the Cold War in 1989, there was throughout Africa a desire for radical change and democracy. I was chosen to represent Kananga in political institutions organizing the rule of law and human rights in the Democratic Republic of Congo.

I moved to Kinshasa and worked as 'The Honorable Mwamba' in the Sovereign National Conference for two years (1991-1992) and was then elected Member of the High Council of the Republic (1992-1994), the supreme authority of the nation. This encouraged the authoritarian President Mobutu to set up a Parliament of Transition in 1992 which lasted until his downfall in 1997.

# As an activist standing against military dictatorships in DR Congo

- Between 1991 and 1997, I was a member of the popular resistance, an alliance between civil society and political parties (USORAL-S), and published (as a member of the National Press Association) numerous articles in the Red Press about the muzzling of opposition and the media, and the imprisonment and assassination of opposition leaders and journalists.
- I advocated, and voted in the Parliament in 1996 for the law instituting freedom of the press.
- Between 1997 and 1999, I fought in the political field (as a member of the UDPS National Committee) and in the media (principally the newspaper *The Alarm*); and organized a clandestine network for designing and distributing leaflets in Kinshasa.
- My advocacy for social justice, human rights, democracy, the rule of law, good governance meant I was harassed, abducted, tortured, and eventually condemned to capital punishment (1998-1999). I escaped being secretly executed as a result of pressure exerted by the press, political parties, Human Rights Non Government Organizations and Western Embassies.

## **UNHCR Refugee in Congo-Brazzaville (2000-2007)**

Between 2001 and 2007, after I had escaped from prison in Kinshasa, and travelled west along the Congo River, I was given refuge as a UNHCR refugee in neighbouring Congo-Brazzaville (a former French Colony). In Congo-Brazzaville, I found many Congolese asylum seekers, living in harsh

conditions, who were not succeeding with their refugee applications. I organised clandestine opposition and undertook to advocate for them to get their refugee status from the UNHCR.

After five years in Congo-Brazaville, we succeeded, in establishing a strong well structured Congolese Community Association that was capable of working alongside the UNHCR and committed to working for the resettlement of the long-standing refugees, who were soon settled in the USA, Canada, Norway, Sweden and Australia.

### My resettlement in Australia

I landed in this wonderful country in 2007; Learned English at AMES Footscray and at Walker Close Community Centre (Williamstown Education Centre); Attended SGP courses and workshops at Spectrum MRC in Preston. In 2008, I started working at Spectrum MRC in the Settlement & Family Relationships Services as the African Parenting Educator for the Congolese community.
